**AN ORDINANCE TO AMEND THE CITY CODE OF THE CITY OF ROME, GEORGIA, AND PARTICULARLY CHAPTER 3, ARTICLE II, SECTION 3-34 THEREOF; TO PROVIDE THAT ALL PERSONS (OTHER THAN POST-CERTIFIED POLICE OFFICERS) WHO WORK AS SECURITY GUARDS IN LIQUOR PACKAGE RETAIL OUTLETS OR ALCOHOL POURING OUTLETS SHALL HAVE AN ALCOHOL SALES PERMIT; TO REPEAL CONFLICTING PROVISIONS; AND FOR OTHER PURPOSES.**

**SECTION I:**

**BE IT ORDAINED** by the Rome City Commission, and it is ordained by authority of same, that Chapter 3, Article II, Section 3-34 of the Code of the City of Rome, Georgia, is hereby amended to provide that any person who is not a POST-certified police officer and who works as a security guard in a retail outlet for the sale of liquor by the package or in an alcohol pouring outlet shall be required to have an alcohol sales permit so that it reads as follows:

**Sec. 3-34. Wearing of alcohol sales permits; application to alcohol control commission; fingerprinting, photographing and other investigation by the police department; employment of person without card; expiration on employee's birthday.**

(a) Any person who works in a retail outlet for the sale of liquor by the package or whose principal responsibility is the service of food or beverage in an alcohol pouring outlet or any person who is not a POST-certified police officer and whose principal responsibility is the provision of security in a retail outlet for the sale of liquor by the package or in an alcohol pouring outlet, whether or not such person is an employee of such retail outlet or pouring outlet, shall apply to the police department for an alcohol sales permit, which shall expire on the person's birthday and be renewable on or before that time on a year to year basis. The fee for the card shall be set forth in the fee schedule book of the city as provided in section 8-36.

*(b) - (d) remain the same.*

(e) No alcohol licensee holder under the provisions of this chapter shall hire any person for, nor permit any person to work or assist in, sales or security at an alcohol pouring outlet or a retail outlet for the sale of liquor by the package, until such person has procured an alcohol sales permit as prescribed in this section.

*(f) - (h) remain the same.*

**SECTION II:**

**BE IT FURTHER ORDAINED** that all ordinances, or parts of ordinances in conflict herewith be, and the same are, hereby repealed.
